As Performer(s), Vendor(s), Artisan(s), Volunteer(s) you agree to utilize personal protective equipment to reduce the risk of exposure while on festival grounds and abide by all safety requirements published by the CDC, Pennsylvania Department of Health and the Allentown Health Bureau; and allow Museum of Indian Culture staff to temperature screen upon your arrival. You agree that you will not attend this event if you have a fever or symptoms of respiratory infection (cough, sore throat, shortness of breath); returned from overseas in the last 14 days; or been in close contact with a confirmed case of COVID-19 (coronavirus) in the last 14 days.
